Conditions for Uploading the Contributions

1. Entry for the competition is open to participants of 18 years and over.

Warranty of Rights and Permissions

1. I hereby warrant that the Contribution shows a photograph of my person, that is, that the Contribution is my own personal contribution and that no minors are shown in the images. Inasmuch as third parties have collaborated in the Contribution, I warrant that I dispose over the necessary rights and permissions of these parties. In particular, I warrant that I observe all the relevant rights of use and ancillary copyrights, as well as other rights to the photograph, and that the photograph and the Contributions are unencumbered by third party claims.
2. Furthermore, I hereby warrant that I observe the rights of all parties visible in this Contribution, in particular their personal image rights and other personality rights, and that all parties agree to the upload, publication, and use of the images. This applies to all parties visible in the images, including, for example, if a person is coincidentally to be seen in the background of the photograph.
3. In addition, I hereby warrant that the Contribution does not violate any applicable law and causes no other objections.
